## Appendix J

Request to Waive Credit-Based Graduation Requirements for Classes of 2020, 2021, and 2022

The Washington State Board of Education (SBE) approved rules giving districts the authority to waive high school credit and pathway requirements for individual students in the classes of 2020, 2021, and 2022 who were on-track to graduate and who were unable to complete credit or pathway requirements due to the COVID disruption.

Under this waiver program, two credits and/or a graduation pathway option may be waived with no more than one credit in each core subject area being waived. Other waivers may be used with this waiver program, including the two-credit waiver for student circumstances, provided a student earns at least twenty total credits. The limit on which credits may be waived is based on what a student was enrolled in or planning to reasonably complete by the end of their graduation year. Students in the class of 2022 may waive the graduation pathway requirement to graduate early but, if doing so, credits may not be waived and all other graduation requirements must be met.

In order for the waiving of course credit, the principal or counselor must consult with the individual student and make a reasonable effort to consult with a parent or guardian of the student. The consultation must include:

- □ What is being waived for the individual student
- □ Advising the student to waive only those credit(s) that are least applicable to the students' postsecondary plans
- □ Potential benefits and limitations that could result from receiving the waiver including impacts on high school graduation and postsecondary plans
- □ The option for the individual student to decline the waiver and for the student to be provided with the opportunity to earn the credits needed to complete graduation requirements through continued enrollment beyond the planned graduation date.

It is important to remember that though students may waive some courses required for high school graduation, the courses may be needed for some colleges, universities, post-secondary employment opportunities or other programs. Before submitting this form, please ensure the course is not needed for post-secondary plans.
