Capital Facilities Plan Adjustments

- Provided draft plan to the board on May 15th and to legal counsel for review.
- Legal counsel recommend revising construction costs to recently bid and opened projects rather than older completed projects that had been used since 2014
 - Changed Appendix E1-E3 from using costs of Sandburg El., Rose Hill Middle and Lake Washington High to using costs for Kirk El., Timberline and Juanita High School.
 - Increase in construction costs causes increase to impact fee calculation
 - Update accurately reflects the building costs per student



Capital Facilities Plan Adjustments

- While the district appropriately updated the plan to accurately reflect construction costs, we realize it is also important to maintain consistency in the impact fee increase
- Provides regular increase of Single-Family fee rather then decrease in original draft
- Multi-Family Fee significantly increased
 - Recommend incrementally stepping up the Multi-Family Fee so that the increase does not occur all in one year.
 - District can provide adjustment beyond the 50% local share
 - Recommend Multi-Family discount be adjusted to 60% for this year in order to step up the fee.
 - Had large increase in MF fee in 2019
 - Shown in plan in Appendix C as "District adjustment"
- No adjustment to Single-Family remains 50% local share
