2019 CAPITAL PROJECTS LEVY, FIRST READING RESOLUTION NO. 2259

November 19, 2018

SITUATION

In 2014, the district formed a Long-Term Facility Task Force to help develop recommendations to reduce overcrowding, accommodate growing enrollment, and continue to provide quality learning environments and experiences for students. Staff and community members provided feedback throughout the process.

In November 2015, the Task Force recommended a long-term strategy through 2029-30 that would guide district decisions and plans for building new schools and enlarging aging schools to address anticipated capacity needs. A Bond Advisory Committee was then consulted to develop the funding plan to support the implementation of the long-term facility recommendations. The funding plan included an April 2016 bond that was passed by voters, a February 2018 bond that was not passed, and future bonds positioned for 2022 and 2026.

The February 2018 bond would have allowed the district to continue adding needed capacity for approximately 2,100 students through facility additions and enhancements but did not receive the required 60% voter approval to pass.

The district continues to have immediate critical capacity needs to be addressed. In order to determine the next course of action, the board received information and considered multiple options for addressing ongoing capacity needs in six study sessions between March and November 2018.

In addition to the work of the board, a Levy Advisory Committee was convened, including community and staff representatives, to provide feedback on the proposed recommendations to the Board. The Advisory Committee met twice in October to review past actions and strategies, enrollment and capacity needs, critical project options and election timelines. The Board received information on preliminary recommendations at two study sessions.

An overview of the Capital Project Levy recommendation will be presented to the board of directors at the regularly scheduled meeting on November 19, 2018. Board action on the measure is scheduled for December 3.

2019 Capital Projects Levy, First Reading Resolution No. 2259 November 19, 2018 Page 2

Resolution No. 2259, Capital Projects Levy, authorizes a six-year levy totaling \$120 million or an average of \$20 million per year for six years. Levy funds would pay for critical projects to address rapid enrollment growth and student safety and security. Proposed projects include: classroom additions at Lake Washington High School, including auxiliary gyms and commons; classroom additions at Carson Elementary, Franklin Elementary, Rose Hill Elementary, and Twain Elementary, including expansion of core facilities where feasible; and district-wide student safety and security upgrades.

The estimated tax rates per \$1,000 of assessed valuation (AV) for 2020, 2021, 2022, 2023, 2024, and 2025 are \$0.29, \$0.28, \$0.27, \$0.26, \$0.25, \$0.25 respectively. The district currently funds construction projects through prior bond measures. With the addition of a 6-year levy, the tax rate for construction will be maintained at the current rate of \$1.16 of \$1,000 assessed valuation (AV) through the combination of prior bonds and the 6-year capital project levy.

The overall tax rate per \$1,000 of assessed valuation, including this measure and previously approved bond and levy measures is estimated to be \$2.60 in 2019 and is estimated to remain at \$2.60 in 2020 and beyond.

King County requires notification of at least 60 days prior to the election date in order to certify the measures for inclusion on the ballot. The deadline for the April 23, 2019 election is February 22, 2019.

RECOMMENDATION

The Board of Directors will take action at the December 3, 2018 board meeting to adopt Resolution No. 2259, Capital Projects Levy.

A RESOLUTION of the Board of Directors of Lake Washington School District No. 414, King County, Washington, providing for the submission to the qualified electors of the district at a special election to be held therein on April 23, 2019, of a proposition to authorize the district to levy an additional tax of \$20,000,000 in 2019 for collection in 2020, \$20,000,000 in 2020 for collection in 2021, \$20,000,000 in 2021 for collection in 2022, \$20,000,000 in 2022 for collection in 2023, \$20,000,000 in 2023 for collection in 2024, and \$20,000,000 in 2024 for collection in 2025 for the District's Capital Projects Fund for constructing and equipping additions to four elementary schools, constructing and equipping additions to Lake Washington High School classrooms, auxiliary gym and commons, and making district-wide building safety and security modifications to meet the current and future educational programs for its students.

WHEREAS, the educational facilities of Lake Washington School District No. 414, King County, Washington (the "District"), are in need of renovation, construction, improvements and expansion to meet the current and future educational programs for its students; and

WHEREAS, funds available to the District will be insufficient to enable the District to implement such projects; and

WHEREAS, in order to support the cost of these projects as found necessary by the Board of Directors, it is deemed advisable that the District levy a tax upon all the taxable property within the District in excess of the annual tax the District is permitted by law to levy without a vote of the people, such levy to be made for six years commencing in 2019 for collection in the school years from 2019-2020 through 2025-2026, inclusive, as authorized by Article VII, Section 2 of the State Constitution and RCW 84.52.053; and

WHEREAS, the question of whether or not such excess tax may be levied must be submitted to the qualified electors of the District for their ratification or rejection; and

WHEREAS, the conditions here and above set forth which requires the holding of a special election in the District;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF LAKE WASHINGTON SCHOOL DISTRICT NO. 414, KING COUNTY, WASHINGTON as follows:

<u>Section 1</u>. <u>Finding</u>. It is hereby found and declared that the welfare of the students and other residents of the District requires the District to carry out the improvements hereinafter provided.

Section 2. Authorization of Improvements. The District shall expand its school facilities through the construction, renovation, improvement and expansion of new and existing facilities, including, but not limited to, constructing and equipping additions to Lake Washington High School classrooms, auxiliary gyms and commons, constructing and equipping additions to Carson Elementary, Franklin Elementary, Rose Hill Elementary and Twain Elementary schools, providing for District-wide upgrades to building safety and security measures, and shall make other capital project expenditures as found necessary by the Board of Directors.

The District may repay any obligations hereafter incurred for the foregoing purposes.

If available funds are sufficient upon completion of the above improvements, the District may undertake additional construction, modernization, and remodeling and make other capital improvements to the facilities of the District, all as approved by the Board of Directors; provided that such funds may be used only to support the construction, modernization, replacement, and remodeling of school facilities or implementation of the District's technology facilities plan.

If the District shall determine that it has become impracticable to accomplish any of such improvements or portions thereof by reason of changed conditions or needs, incompatible

development, costs substantially in excess of those estimated, or acquisition by a superior governmental authority, the District shall not be required to accomplish such improvement and may apply levy proceeds as set forth in this section. If any or all of the improvements have been completed, or their completion duly provided for, or their completion found to be impractical, the District may apply the levy proceeds or any portion thereof to other portions of the improvements or to other capital purposes of the District, as the District in its discretion shall determine. Notwithstanding any provision of this resolution to the contrary, levy proceeds may only be used to support the construction and remodeling of school facilities.

Section 3. Authorization of Levies. It is hereby found and declared that best interests of the District require the submission to the qualified electors of the District of the proposition whether the District shall make the Capital Projects Fund levies for their ratification or rejection at a special election to be held on April 23, 2019. For the purpose of providing funds necessary for the needs described in Section 2 above, King County Elections, as *ex officio* supervisor of elections in King County, is hereby requested to call and conduct such special election to be held within the District on such day and to submit to the qualified electors of the District for their approval or rejection, a proposition providing for tax levies for the Capital Projects Fund for six years, commencing in 2019, producing dollar amounts at estimated tax rates per thousand dollars of assessed value to produce such amounts, in excess of the maximum amount tax levy permitted by law to be levied within the District without a vote of the electors, all as follows:

- A. \$20,000,000, said levy to be made in 2019 for collection in 2020;
- B. \$20,000,000, said levy to be made in 2020 for collection in 2021;
- C. \$20,000,000, said levy to be made in 2021 for collection in 2022;
- D. \$20,000,000, said levy to be made in 2022 for collection in 2023;

- E. \$20,000,000 said levy to be made in 2023 for collection in 2024; and
- F. \$20,000,000 said levy to be made in 2024 for collection in 2025.

The estimated levy rate depends upon the final dollar amount of assessed value of the property within the District. At this time, based upon information provided by the County Assessor's office, the estimated levy rate for the 2019 levy is \$0.29 per thousand dollars of assessed valuation, the estimated levy rate for the 2020 levy is \$0.28 per thousand dollars of assessed valuation, the estimated levy rate for the 2021 levy is \$0.27 per thousand dollars of assessed valuation, the estimated levy rate for the 2022 levy is \$0.26 per thousand dollars of assessed valuation, the estimated levy rate for the 2023 levy is \$0.25 per thousand dollars of assessed valuation, and the estimated levy rate for the 2024 levy is \$0.25 per thousand dollars of assessed valuation. The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

Section 4. Voters' Pamphlet. Pursuant to authority granted by RCW 29A.32.220, the Board of Directors hereby authorizes the District's participation in the local voters' pamphlet for the April 23, 2019 election and requests that King County Elections prepare and publish a voters' pamphlet for this proposition. The District understands and agrees that it will be required to pay its proportionate share of the expenses of the voters' pamphlet.

<u>Section 5</u>. <u>Approval of Form of Ballot</u>. The Secretary of the Board of Directors is hereby authorized and directed to certify said proposition to King County Elections, as *ex officio* supervisor of elections in King County, substantially in the following form:
