## Results and Analysis

# Survey Overview & Technical Notes

---

Lake Washington School District is considering expanding opportunities for high school students to take more classes. In order to assess demand, parents and students were asked to take a short survey about their interest in adding an additional class period to the high school schedule.

The survey was open from December 5 – 20, 2013. Parents participated via a public link, while students received invitations through their school email addresses.

Demographic information included grade level and school site.

Since results do not reflect random sampling, they should not be generalized to entire populations. Rather, results reflect the perceptions and opinions of those groups who responded to the survey.

# Executive Summary

---

Overall, both students and parents are interested in the addition of a seventh period class to the high school schedule. Arts, Occupational Education and Science were the three most requested subject areas to study during an additional class period.

Seven out of 10 students requested shortening the current six class periods to allow for the addition of a seventh period class, while 6 out of 10 parents requested a 60-minute seventh period be added to the end of the current schedule.

About 30% of students and 20% of parents reported that transportation would become a challenge if an additional class period were added outside of the current high school schedule. About 60% of those parents said the transportation challenge would be eliminated if bus service was provided.

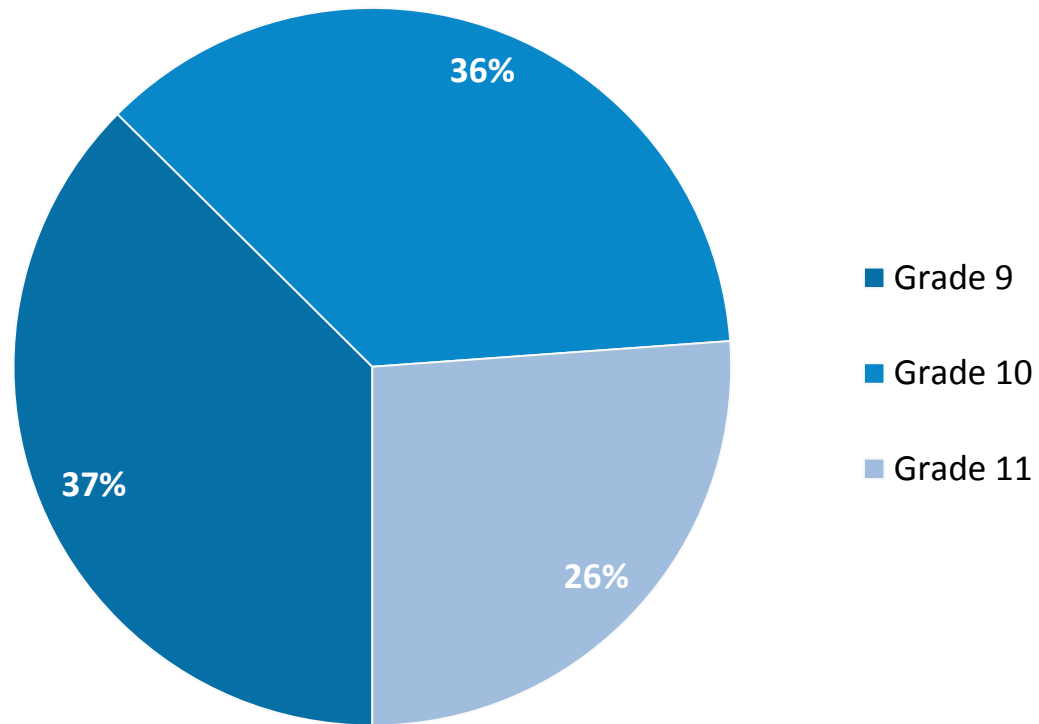

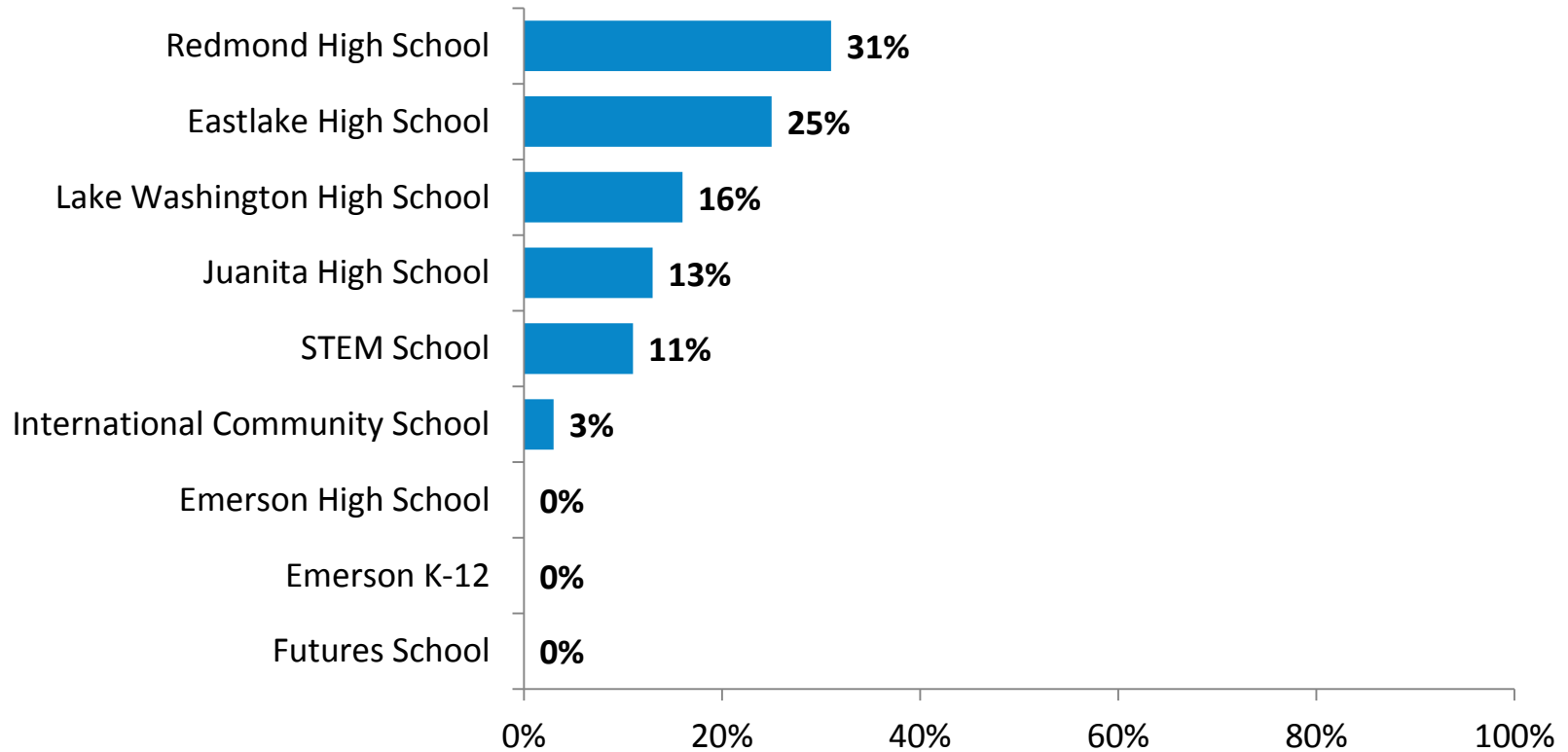
Please select your grade level. (N=1,993)

Please select your school. (N=2,002)



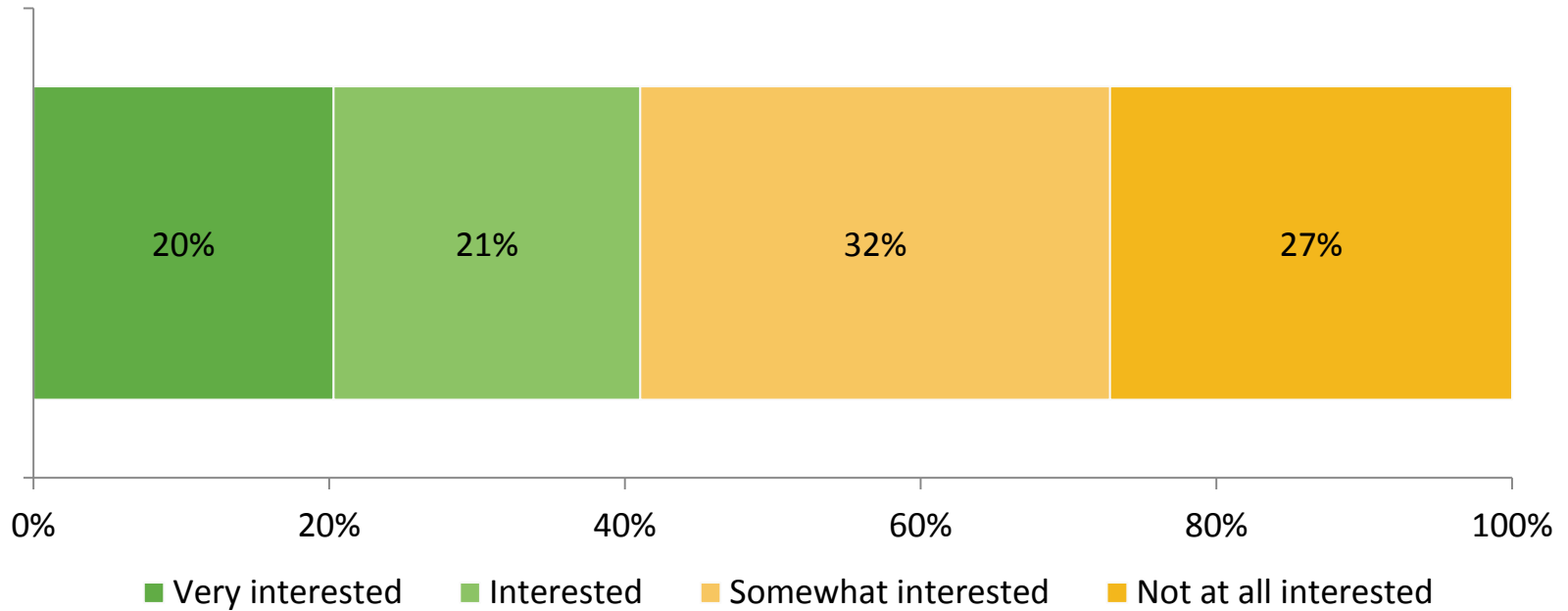

# Open-Ended Responses

---

## Please share why you are not interested in taking an additional class. (N=512)

Students wrote that their current workload is already too much.

Students are not interested because an extra period would result in more homework.

Students are worried about the increased stress they would feel if they had to take an additional class.

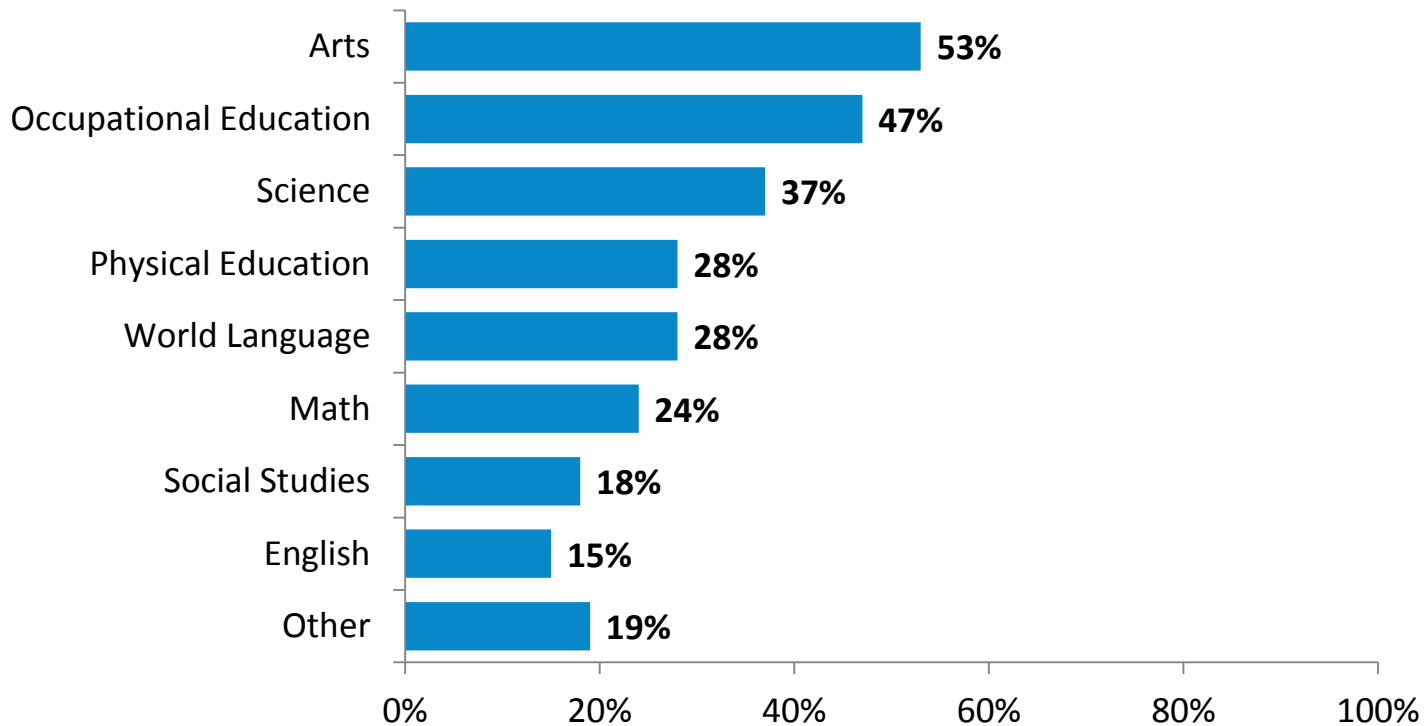
Students wrote about how busy their schedules are currently. Many wrote that they work and/or are involved in extracurricular activities and think that the addition of another period will result in an even busier schedule.

Students do not want a longer school day.

Please select the subject areas you would be interested in studying during a seventh class. (N=1,449)



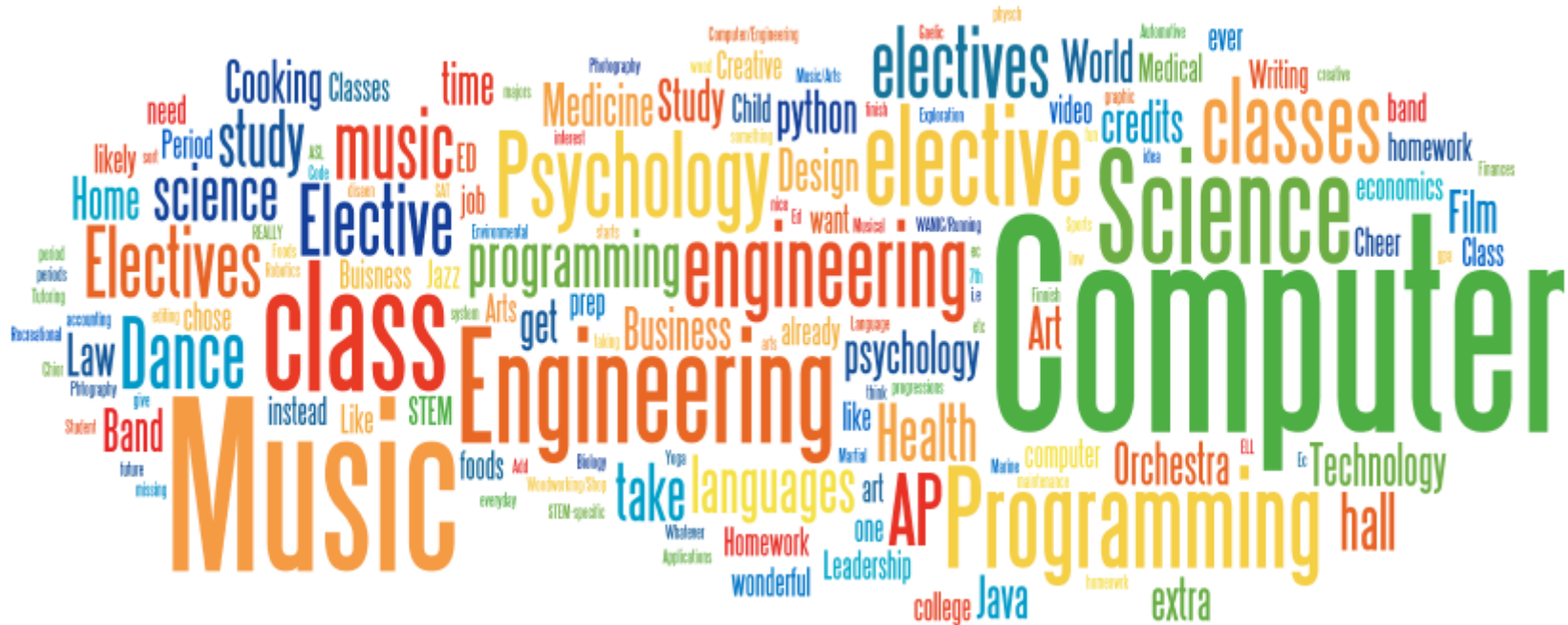

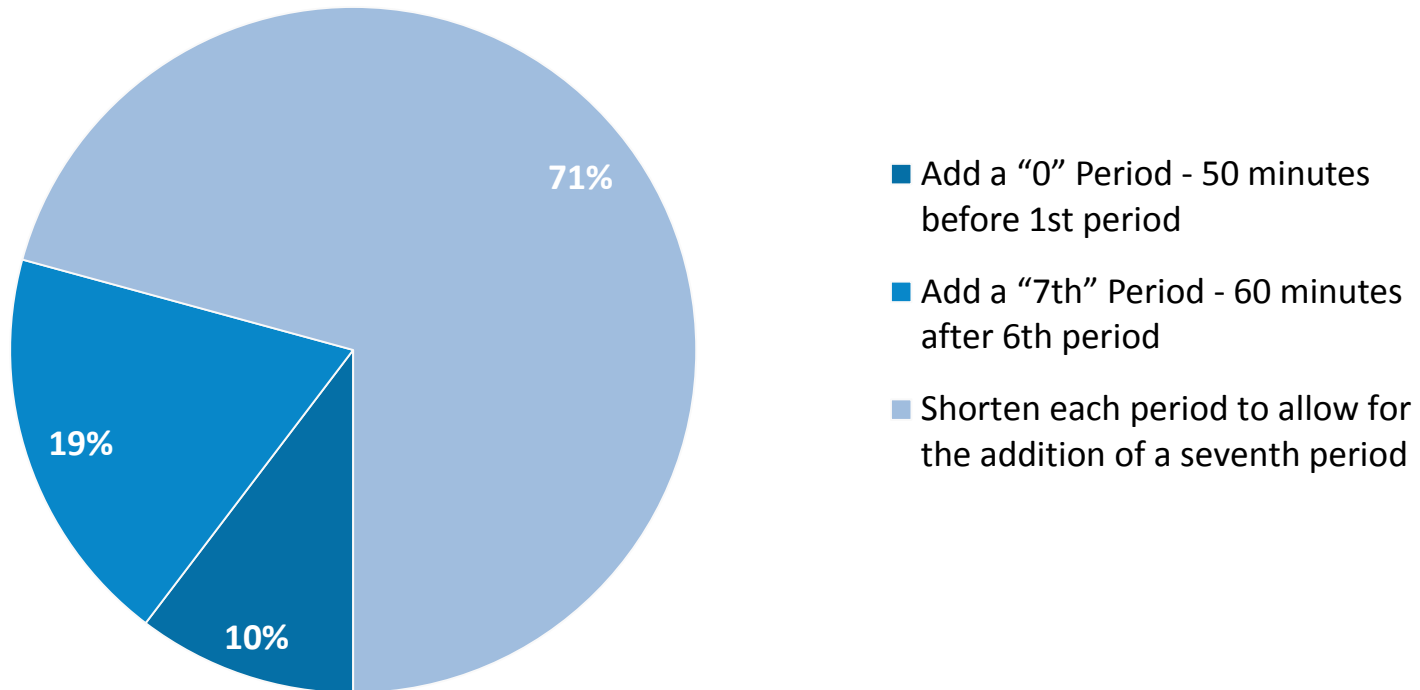
Please select the subject areas you would be interested in studying during a seventh class. (N=278)

In your opinion, how should the high school schedule change to allow for the potential addition of a seventh class? (N=1,460)

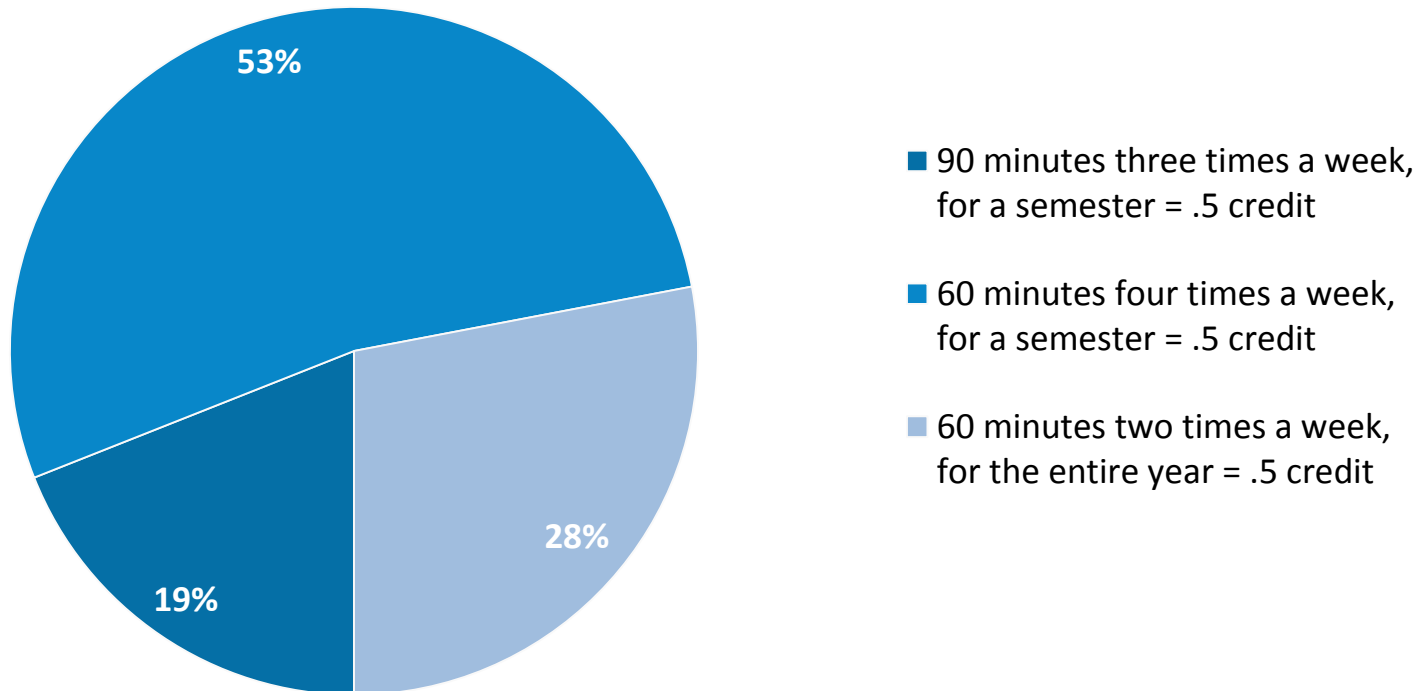

Which 7<sup>th</sup> period model do you prefer? (N=273)

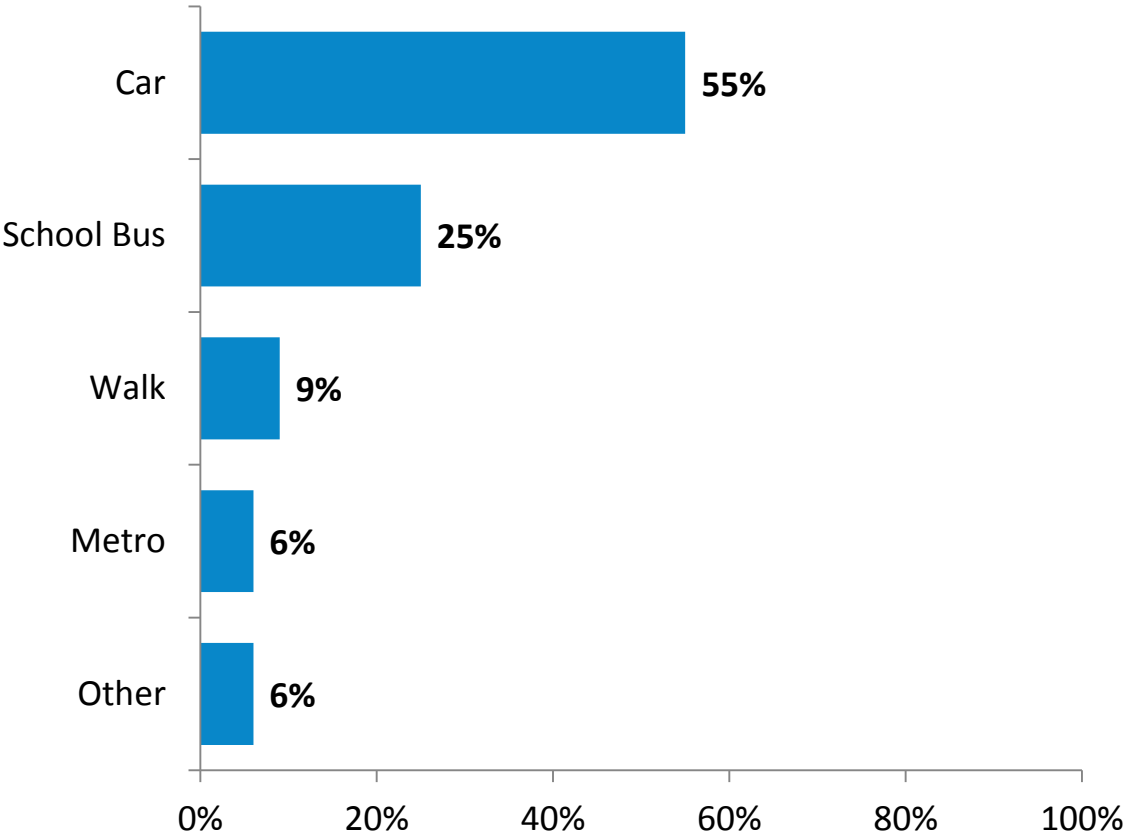

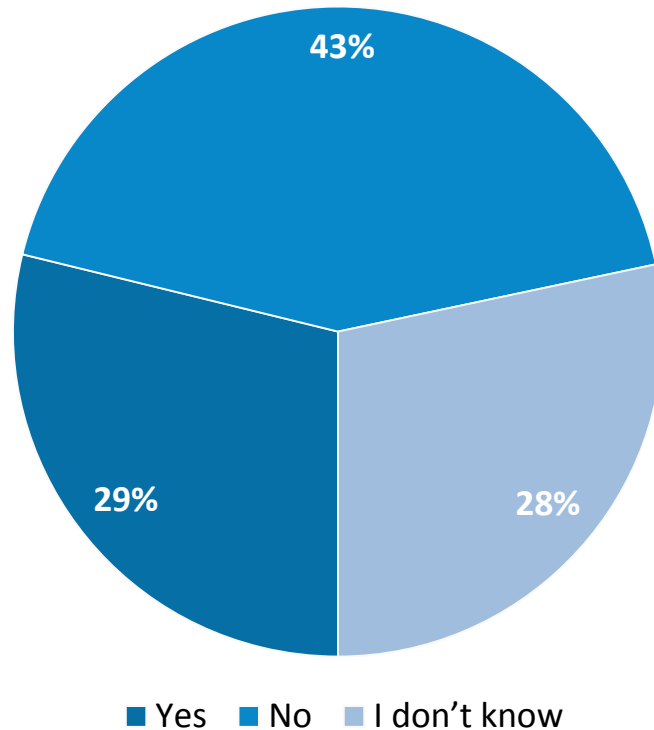

Generally, how do you travel to and from school each day? (N=1,994)

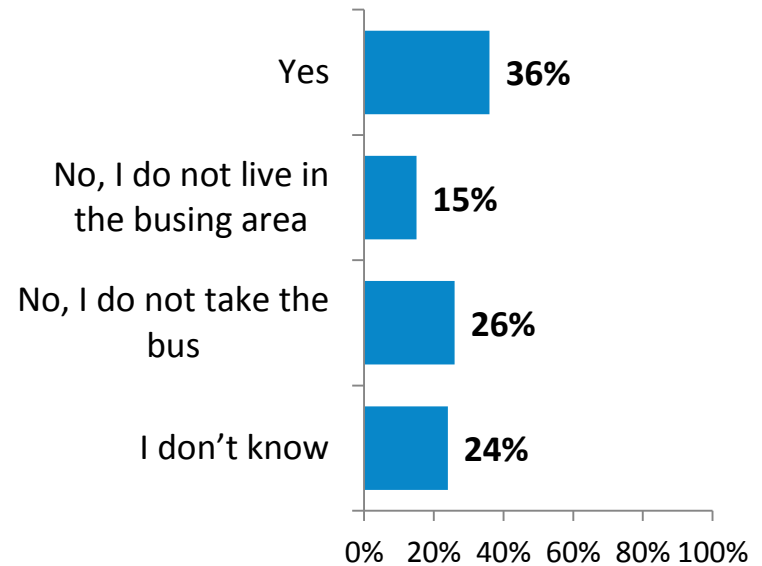


# Transportation Challenges

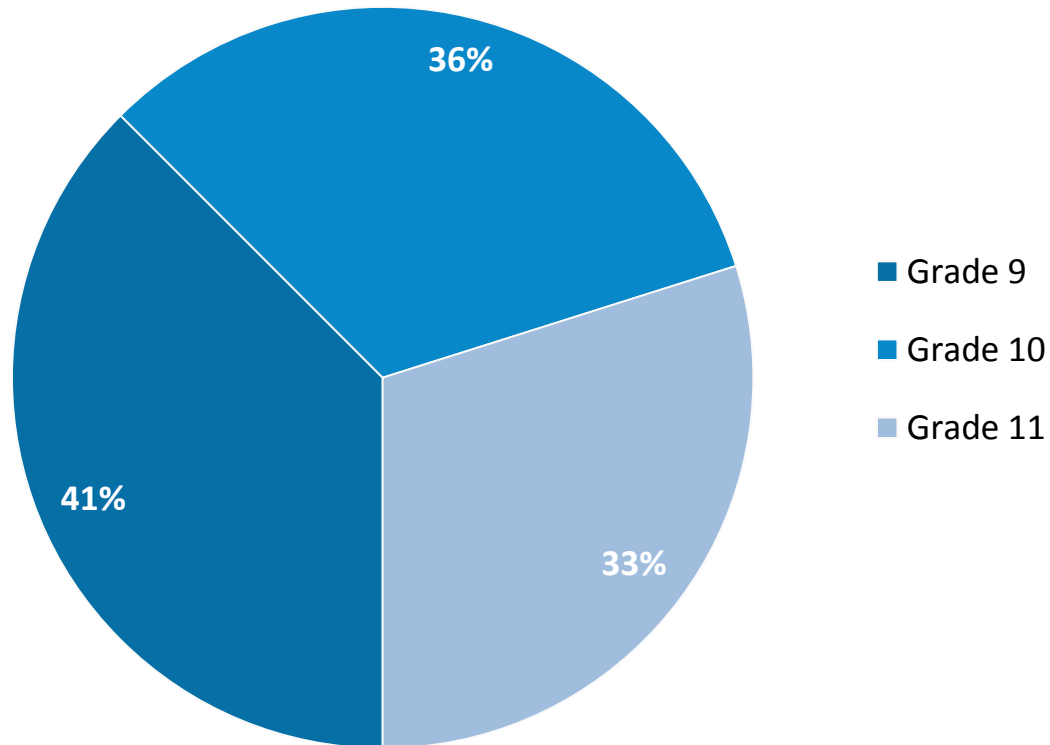

# Participation by Grade

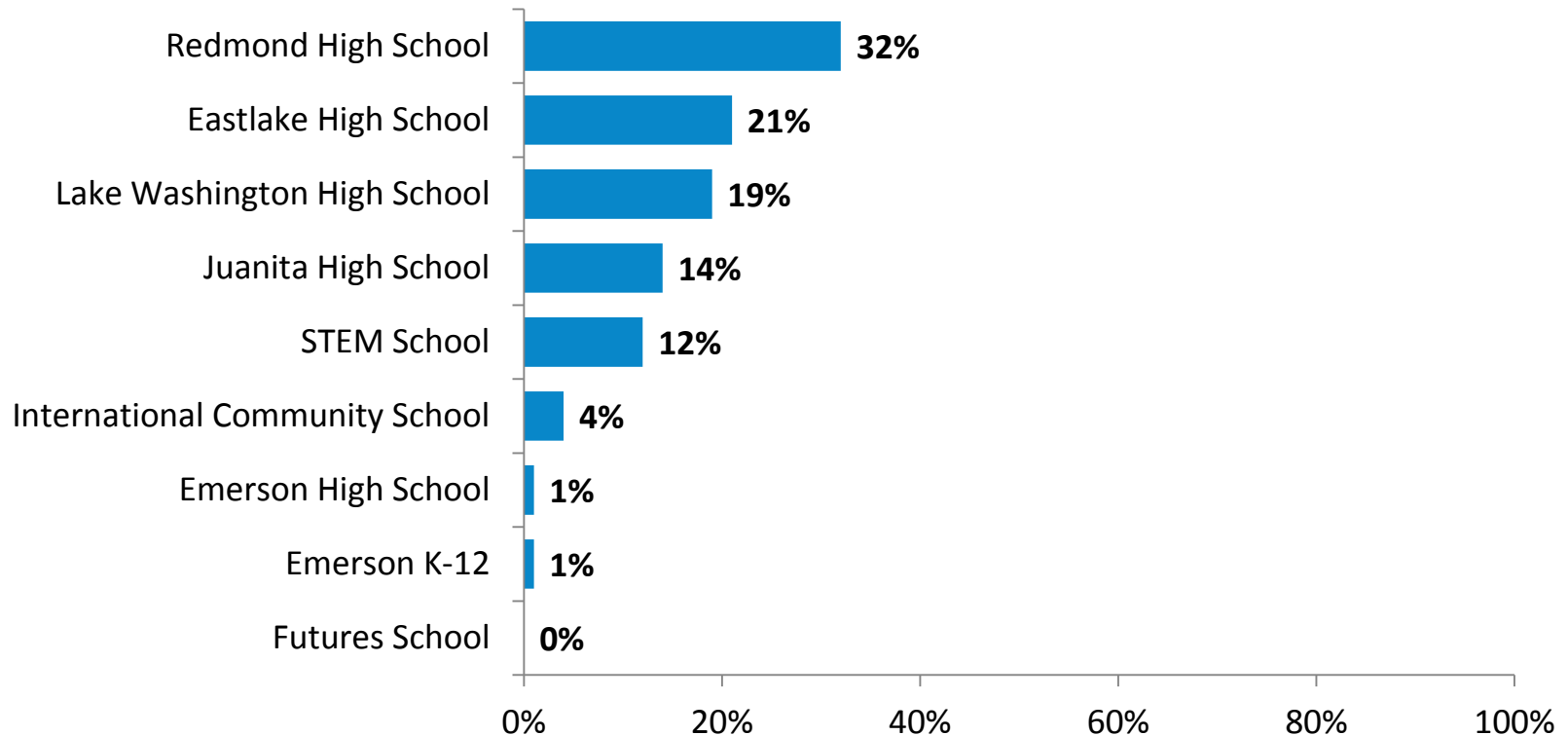

Please select your child's school. (N=1,026)



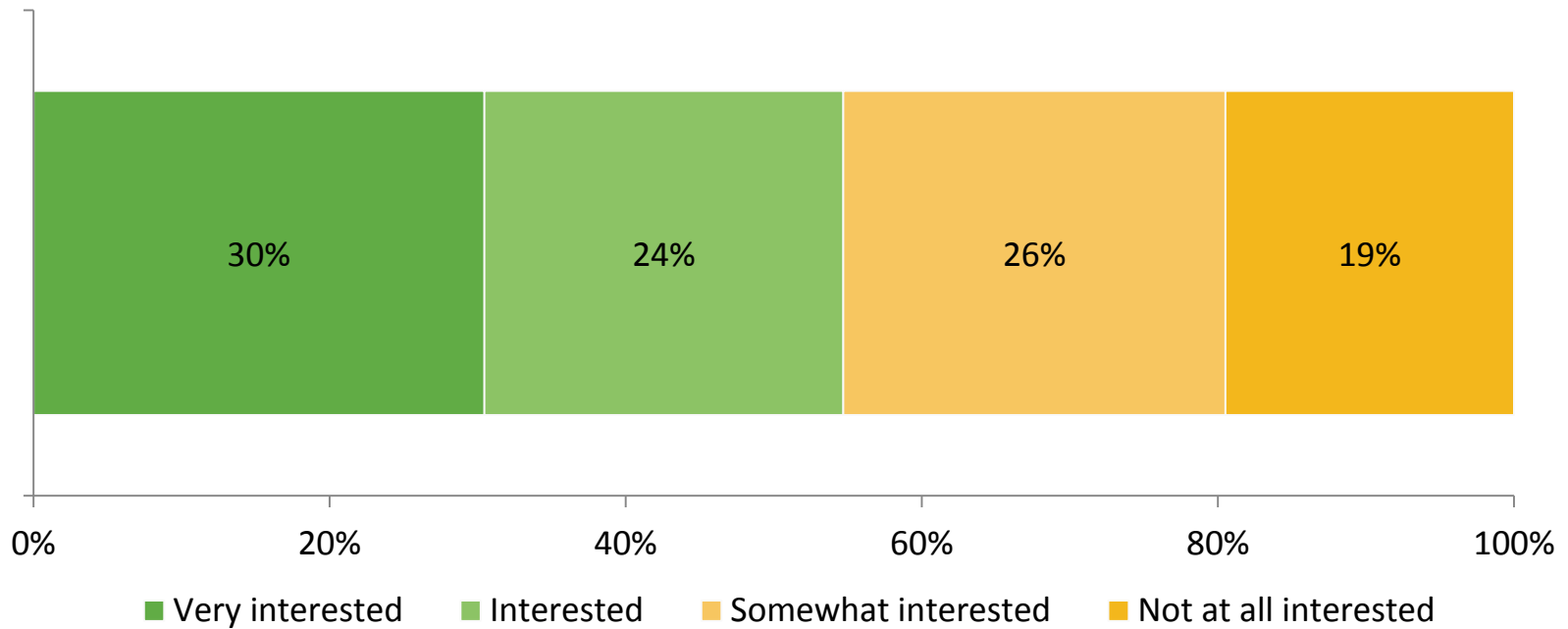

# Open-Ended Responses

---

## Please share why you are not interested in your child taking seven classes. (N=178)

Many participants wrote that the amount of homework their child currently has is already substantial enough, and that adding another period would result in more work which would be unmanageable.

Participants wrote of fears that the addition of a 7<sup>th</sup> period may result in less “free” time outside of school to do things such as spend time with family, work and participate in extracurricular activities.

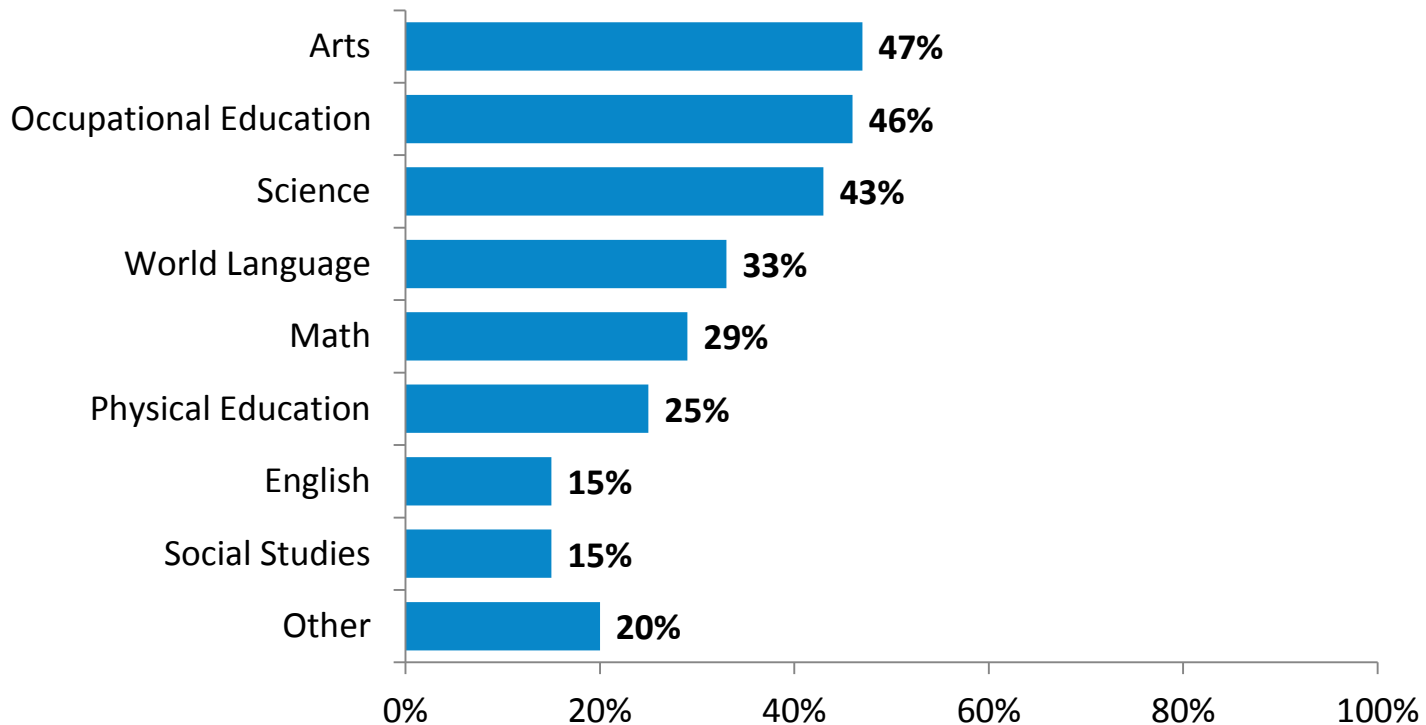
Participants believe that the addition of a 7<sup>th</sup> period will result in increased stress on students.

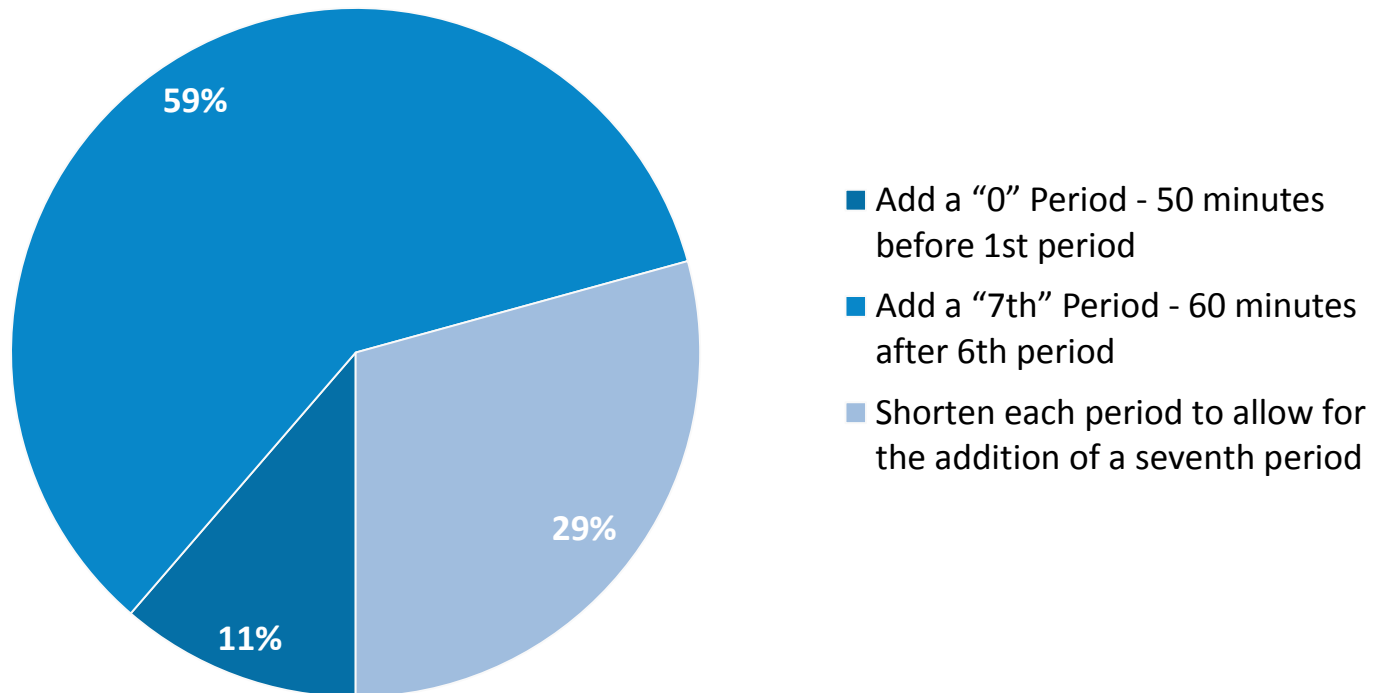

In your opinion, how should the high school schedule change to allow for the potential addition of a seventh class? (N=830)

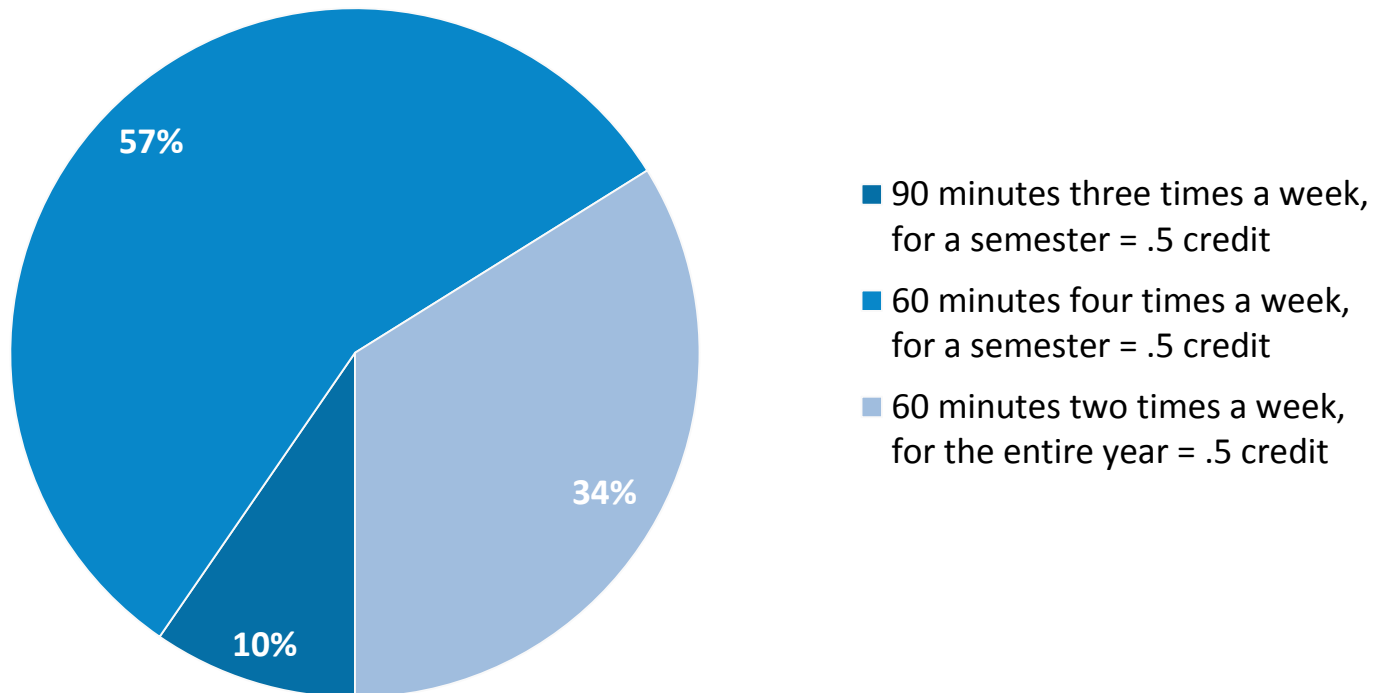

Which 7<sup>th</sup> period model do you prefer? (N=490)



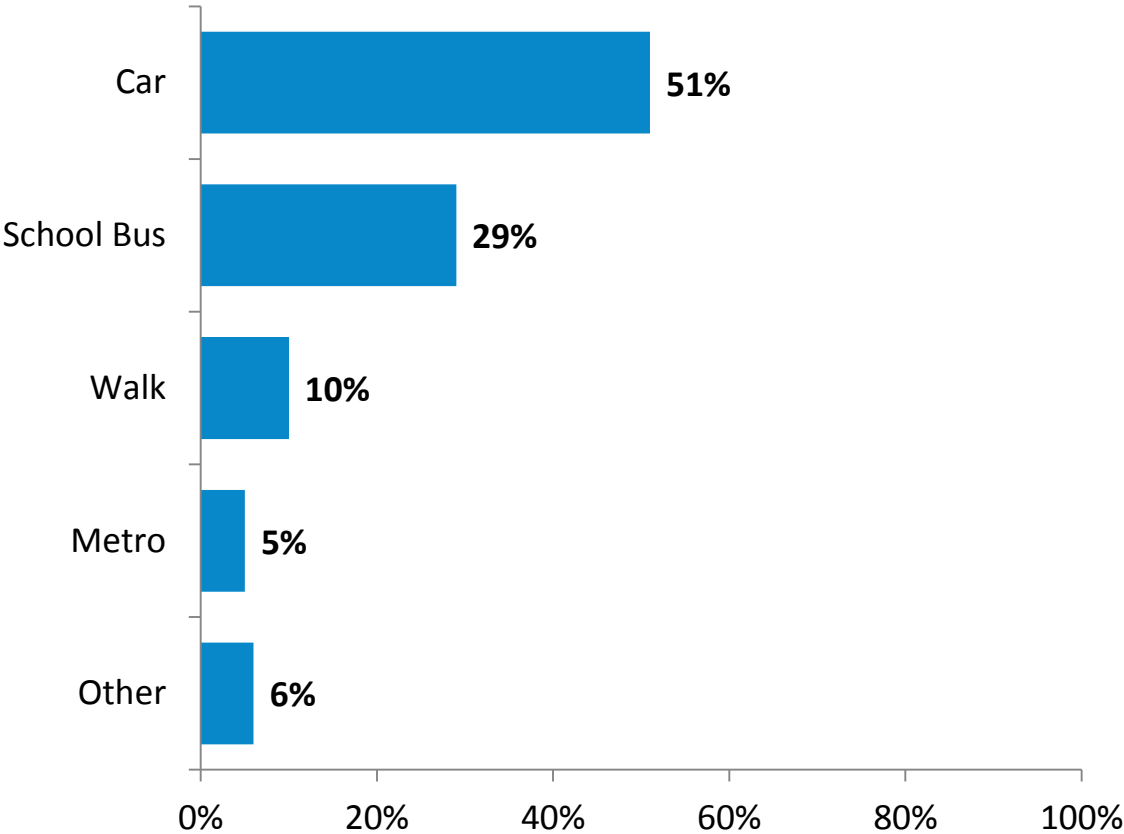

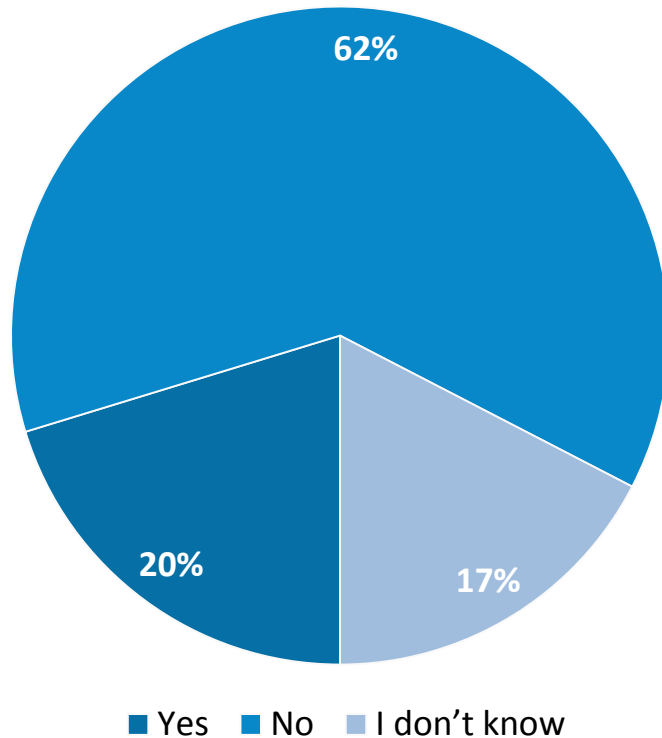

Generally, how does your child travel to and from school each day? (N=1,027)

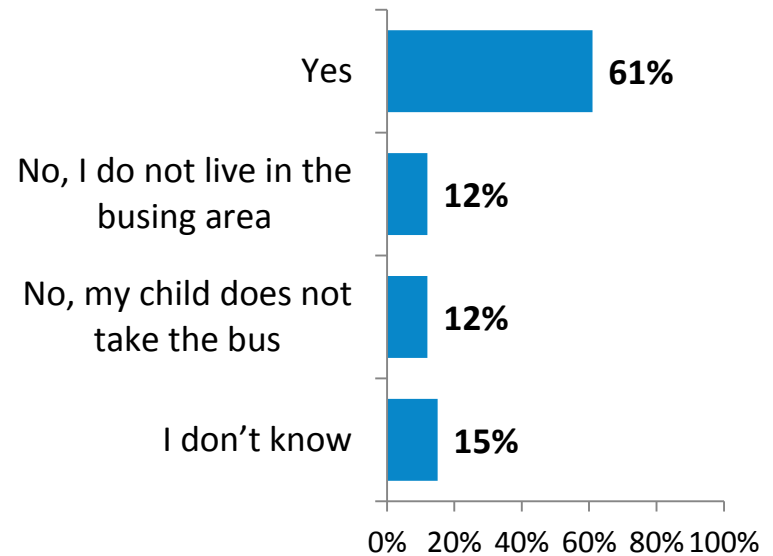


# Transportation Challenges
