LWSD Highly Capable Programs Change of Service Request

Parents of students participating in LWSD highly capable services may opt to withdraw from highly capable services at any time by submitting the Change of Service Request to the Accelerated Programs Office. Students will remain identified as highly capable. Students attending a LWSD school may receive differentiated instruction in their LWSD classroom. Students opting out of Full-time Quest may request participation in either Pull-out Quest or K-5HC services. Students opting out of Pull-out Quest may request participation in K-5HC services.

If parents wish to have their student return to highly capable services, they may submit a <u>Change of Service Request</u>. Students who have been away from highly capable services for less than 12 calendar months may resume the same level of highly capable services. For an absence of longer than 12 calendar months, parents may submit a written request to resume highly capable services and attach report card grades and evidence that the student has participated in accelerated learning; the Multidisciplinary Selection Committee will consider the request.

Parents of newly identified highly capable students may opt to decline services. Students will remain identified as highly capable. Students attending a LWSD school may receive differentiated instruction in their LWSD classroom. After declining highly capable services, parents who wish to begin previously offered services may complete a <u>Change of Service Request</u>. Students wishing to begin services within 12 calendar months of the original start date will be scheduled for the same level of service. Requests for highly capable services starting more than 12 calendar months after the original start date must be reviewed by the Multidisciplinary Selection Committee; submit a Change of Service Request along with report card data and documentation showing accelerated learning for review.

NOTES:

Students must reside in LWSD boundaries to participate in LWSD highly capable services. School assignment and classroom placement are subject to change.
